Minimum placement of 70% for all qualifiers.

IMO: Tier 14 and above | MGA: Non-Producer/Agency/Distributor: Tier 13 and below

QUALIFICATION AND ATTENDANCE DETAILS

Participation is reserved exclusively for licensed SBLI producers, MGAs and IMOs who are contracted with IIP and in good standing with SBLI.

Eligible Paid Premium is defined as metrics tied to policies with an Application Received Date within the qualifying year.

Policies written on an agent's life, their spouse and/or children will not count.

Conversions are not included.

Writing agent: the agent number listed on the application receives the paid premium credit as the writing agent, except on split cases. All agents on split cases receive the proportional paid premium credit.

IMO/MGA: Qualification amounts include personal production.

Policy termination(s) could be disqualifying if the minimum qualifications are no longer met as a result. Negative commission balances must be resolved to attend.

SBLI will determine program qualifiers based on calculated results. Attendance is voluntary and this award is non-transferable, with no cash equivalent substitution.

In Connecticut, SBLI sells under Centrian Life Insurance, a registered trade name and Connecticut DBA of SBLI. SBLI and Centrian Life Insurance will follow IRS guidelines regarding tax reporting in connection with this event. Federal/state income tax incurred as a result of attending is the qualifier's responsibility. Qualifiers should consult their tax advisor regarding tax treatment.

Attendees must comply with SBLI's code of conduct. SBLI has full discretion to cancel or reschedule and SBLI Senior Vice President & Chief Distribution Officer has full discretion to settle any award question or dispute.
